The Grand Jurors of Maricopa County, Arizona, accuse DJIMON BOGGS, on October 18, 2023, charging that in Maricopa County, Arizona:

COUNT 1

DJIMON BOGGS, on or about September 15, 2023, with intent to commit a theft or a felony therein, did enter or remain unlawfully in or on the residential structure of VICTIM A, AND/OR SERENA RAMIREZ, AND/OR LINDSAY COLTON located at 8th Street and Gary Drive, Tempe, Maricopa County, while he or his accomplice knowingly possessed an explosive, a deadly weapon, or a dangerous instrument, to-wit: handgun, in violation of A R S §§ 13-1501, 13-1508, 13-1507, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a

handgun, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

COUNT 2:

DJIMON BOGGS, on or about September 15, 2023, using a handgun, a deadly weapon or dangerous instrument, intentionally did place VICTIM A in reasonable apprehension of imminent physical injury, in violation of A.R.S. §§ 13-1203, 13-1204, 13-3105, 13-701, 13-702, and 13-801

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a handgun, a deadly weapon or dangerous instrument, in violation of A R S §§ 13-105 and 13-704

COUNT 3:

DJIMON BOGGS, on or about September 15, 2023, intentionally or knowingly, did attempt to engage in sexual intercourse or oral sexual contact with VICTIM A, without the consent of VICTIM A, in violation of A R S. §§ 13-1001,13-1406, 13-1401, 13-3821, 13-610, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a handgun, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704

COUNT 4

DJIMON BOGGS, on or about October 6, 2023, with intent to commit a theft or a felony therein, did enter or remain unlawfully in or on the residential structure of VICTIM B, located at 8th Street and Gary Drive, Tempe, Maricopa County, while he or his accomplice knowingly possessed an explosive, a deadly weapon, or a dangerous instrument, to-wit: knife and/or handgun, in violation of A.R.S. §§ 13-1501, 13-1508, 13-1507, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a knife and/or handgun, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704

COUNT 5:

DJIMON BOGGS, on or about October 6, 2023, using a knife, a deadly weapon or dangerous instrument, intentionally, knowingly or recklessly did cause a physical injury to VICTIM B, in violation of A.R.S. §§ 13-1203, 13-1204, 13-3105, 13-701, 13-702, and 13-801

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a knife, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704

COUNT 6

DJIMON BOGGS, on or about October 6, 2023, intentionally or knowingly, did engage in sexual intercourse or oral sexual contact with VICTIM B, without the consent of VICTIM B (to wit: first time, penile/vaginal), in violation of A R.S §§ 13-1406, 13-1401, 13-3821, 13-610, 13-701, 13-702, and 13-801

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a knife and/or handgun, a deadly weapon or dangerous instrument, in violation of A R S §§ 13-105 and 13-704

COUNT 7

DJIMON BOGGS, on or about October 6, 2023, intentionally or knowingly, did engage in sexual intercourse or oral sexual contact with VICTIM B, without the consent of VICTIM B (to wit. penile/anal), in violation of A R S §§ 13-1406, 13-1401, 13-3821, 13-610, 13-701, 13-702, and 13-801

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a knife and/or handgun, a deadly weapon or dangerous instrument, in violation of A R S. §§ 13-105 and 13-704

COUNT 8:

DJIMON BOGGS, on or about October 6, 2023, intentionally or knowingly, did engage in sexual intercourse or oral sexual contact with VICTIM B, without the consent

of VICTIM B (to wit last time, penile/anal, in violation of A R S §§ 13-1406, 13-1401, 13-3821, 13-610, 13-701, 13-702, and 13-801

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a knife and/or handgun, a deadly weapon or dangerous instrument, in violation of A R.S §§ 13-105 and 13-704

COUNT 9.

DJIMON BOGGS, on or about October 6, 2023, knowingly did restrain VICTIM B with the intent to inflict death, physical injury, or a sexual offense on her or to otherwise aid in the commission of a felony, in violation of A R S §§ 13-1304, 13-1301, 13-701, 13-702, and 13-801

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a knife and/or handgun, a deadly weapon or dangerous instrument, in violation of A R.S §§ 13-105 and 13-704

COUNT 10.

DJIMON BOGGS, on or about October 12, 2023, with the intent to commit a theft or a felony therein, did enter or remain unlawfully in or on the residential structure of VICTIM C, located at 8th Street and Gary Drive, Tempe, Maricopa County, in violation of A R S §§ 13-1507, 13-1501, 13-701, 13-702, and 13-801

COUNT 11


DJIMON BOGGS, on or about October 12, 2023, knowingly did restrain VICTIM C with the intent to inflict death, physical injury, or a sexual offense on her or to otherwise aid in the commission of a felony, in violation of A R.S §§ 13-1304, 13-1301, 13-701, 13-702, and 13-801.

COUNT 12.

DJIMON BOGGS, on or about October 12, 2023, intentionally or knowingly, did attempt to engage in sexual intercourse or oral sexual contact with VICTIM C, without the consent of VICTIM C, in violation of A R S §§ 13-1001,13-1406, 13-1401, 13-3821, 13-610, 13-701, 13-702, and 13-801.


