**COUNT 1:** AGGRAVATED ASSAULT, A  
CLASS 3 FELONY Dangerous (Jack Jay  
Woods)

**COUNT 2:** AGGRAVATED ASSAULT, A  
CLASS 6 FELONY (Kyler Matthew  
Renner, Gage Silas Garrison, and Jack  
Jay Woods)

The Grand Jurors of Maricopa County, Arizona, accuse KYLER MATTHEW RENNER, GAGE SILAS GARRISON, AND JACK JAY WOODS on February 2, 2024, charging that in Maricopa County, Arizona:

**COUNT 1:**

JACK JAY WOODS, on or about December 3, 2022, using brass knuckles, a deadly weapon or dangerous instrument, intentionally, knowingly or recklessly did cause a physical injury to Hector Armando Villa Hernandez, in violation of A.R.S. §§ 13-1203, 13-1204, 13-3105, 13-301, 13-302, 13-303, 13-304, 13-501, 8-341, 8-327, 13-701, 13-702, and 13-801.


The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a brass knuckles, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

**COUNT 2:**

KYLER MATTHEW RENNER AND GAGE SILAS GARRISON AND JACK JAY WOODS, on or about December 3, 2022, intentionally, knowingly or recklessly did cause physical injury to Hector Armando Hernandez Villa, while his capacity to resist was substantially impaired, in violation of A.R.S. §§ 13-1203, 13-1204, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801.


